

Location

Luton is a major commercial centre located 33 miles north of London and is situated adjacent to junctions 10 & 11 of the M1 Motorway.

Randstad Court is situated on the south side of Laporte Way at its junction with Kingsway having easy access to the A505 Dunstable Road which links with junction 11 of the M1 Motorway.

The town also benefits from direct rail links to St Pancras International and the presence of London Luton Airport.

Description

Randstad Court comprises a headquarters office building located on Laporte Way which forms one of Luton's main industrial and business locations approximately 1 mile north west of the town centre and 1.5 miles east of the M1 Motorway.
